Holders of the Federal Vocational Baccalaureate are entitled to enrol in the first cycle of studies (bachelor's degree) at Swiss universities of applied sciences according to Art. 25 no. 1 let. a of the Higher Education Act (HEdA) (SR 414.20).

The transcript of the federal vocational baccalaureate is a decision reached by the Canton of Bern Commission responsible for the Federal Vocational Baccalaureate. An appeal against this decision may be lodged with the Department of Education of the Canton of Bern (Sulgeneckstrasse 70, 3005 Bern) within 30 days. In all subjects, grades from 1 to 6 are used to assess the learner's performance. 6 is the highest, 1 the lowest grade. Grades 4 or higher are passing scores, grades below 4 are insufficient scores. A student is awarded the federal vocational baccalaureate if

- a) the average grade is 4 or above
- b) not more than two subjects are below 4
- c) the difference between the insufficient grades and grade 4 does not exceed 2
